- 4. Examine criminal court systems and adversarial concepts
- 5. Examine correctional systems and the purposes of punishment
- 6. Define the basic differences between juvenile and adult systems
- 7. Identify emerging and international forms of justice

  - 2. Understand the historical and philosophical foundations of the modern criminal justice system.

  - 5. Understand the relationship between the U.S. Constitution, U.S. Supreme Court decisions, and the components of the criminal justice system.
  - Name the four possible outcomes which can occur after a law enforcement officer has completed a criminal investigation and explain how each outcome affects the criminal justice system.
  - 7. Define arraignment and describe in detail what happens at an arraignment.
  - 8. Define the terms extradition, probation, parole, pardon, and set-aside.
  - 9. Identify who may file or press charges in a criminal case in Nebraska.
  - 10. Distinguish between the Constitution, the Declaration of Independence, and statutes.
  - 11. Identify the amendments in the Bill of Rights and state the purpose of the Bill of Rights.
  - 12. Define and identify examples of the doctrines of:
    - a) Judicial Review
    - b) Void for Vagueness
    - c) Selective Incorporation

13. Identify the three areas in the criminal justice system which require fair procedures and describe how the due process affects government action in those areas.
